I have no right of approval and no claim for compensation, and I release and discharge Company and its employees, subsidiaries, affiliates, agents, successors, licensees and assigns, and anyone acting under their authorization, from any claims, actions, demands, liability, losses, costs and expenses (including reasonable attorneys' fees) of any kind or nature arising out of the activities authorized under this release, including but not limited to any claims based upon defamation, right of publicity or invasion of privacy. I hereby warrant and represent that I have the right to enter into this release and to grant the rights granted herein.


